

APPOINTMENTS TO BOARDS AND COMMITTEES: WHAT DOES CABINET NEED TO NOTE?

Tuesday, 19 December 2017

Appointments to boards or committees need to be brought to Cabinet to note where the board is of major significance, the board's membership is less than 50% female, or the proposed appointment is a male. All appointments to be made by the Governor must also be brought to Cabinet Subcommittee.

The list below shows which boards need to come to Cabinet and in what form. If a board is not listed below, it is not required to come to Cabinet unless the proposed candidate is male. However, the responsible minister may still ask Cabinet to note an appointment if he or she sees a reason to do so.
