PREMIER'S OVERSEAS TRAVEL OUTCOME REPORT

This year, South Australia celebrates the 30th anniversary of its Sister State/Province relationship with Shandong. For many years this relationship focussed on cultural and educational exchanges and activities, but in recent years there has been a significant increase in commercial activity.

This was the largest business mission to leave the State, reflecting the importance our local businesses place on seeking trade and investment opportunities outside of South Australia to grow their business and create new jobs. The mission included 107 individual businesses and approximately 170 business delegates. Their activities included business fairs in Jinan, Zibo, Yantai, Linyi and Qingdao where they were matched with businesses to develop commercial activities.

In addition to the signing of more than 30 MOUs, many of which are commercially oriented, the mission accomplished the following:

- Number of new business connections 372
- Prospective export leads and estimated value 129 leads valued at approximately AU\$50.4 million.
- Export deals secured 12 deals valued at approximately AU\$524,000.
- New investment leads 52 leads identified with one valued at approximately AU\$20 million.

The main objectives of the Mission were to support the business mission to Shandong, strengthen my personal relationship and hence the Government's relationship with the senior leadership of Shandong Province and to lead discussions with international firms in China seeking to invest in South Australia.

In Beijing I met with the Ambassador to China, Jan Adams, for a country briefing before witnessing the signing of an agreement between mining company Iron Road and China Rail, which should support the construction of necessary infrastructure, which will in turn support the viability of the mine. In addition, the Chief Executive of the Department of the Premier and Cabinet (DPC) signed a MoU between China Rail and the Government on supporting China Rail's broader plans for investment in Infrastructure in the State.

In Shandong the anniversary celebrations included a basketball series between the Adelaide 36ers and Shandong Hi-Speed in four cities across the province culminating in a match in the capital, Jinan, for the Shandong – South Australia Friendly Cup, won by the Adelaide 36ers.

Additionally there were a number of other cultural activities including performances by the Adelaide Symphony Orchestra in Jinan, Slava and Leonard Grigoryan in Qingdao and a joint show by the Qingdao and Adelaide Fashion Festivals in Qingdao. A major hit of the cultural element of the Mission were performances by James Morrison and members of his Mount Gambier Jazz Academy.

In Jinan I also visited Inspur Group Pty Ltd, one of China's largest IT companies which developed part of the world's fastest super-computer. Discussions resulted in a MoU that included a commitment from the State Government to establish a cloud data centre in South Australia that would serve the rest of Australia and, potentially, the broader Asia Pacific. The Investment Attraction Agency is working with the company to develop a Heads of Agreement in time for a return visit from a Shandong delegation in September.

In Qingdao, I witnessed the signing of a number of agreements including one between the Royal Adelaide Club (an offshoot of the Royal Croquet Club) under which they will be establishing a 5000^{m2} presence at the Qingdao International Beer Festival through August 2016 and 2017. The presence at the Festival will be used to promote South Australia as a tourism and education destination to the two million visitors to the site and also provide a space for South Australian businesses to host promotional activities.

I also announced the establishment of Australia's (and possibly the English speaking world's) first State funded Chinese bi-lingual school. The school will be established at William Light R-12 in Plympton and Shandong Education has committed to providing staff to assist in the transition of the school from the beginning of the 2017 school year.

I travelled to Guangzhou where I met with the Chief Operating Officer of China Southern Airlines to discuss the State's bid to have the airline commence a direct service to Adelaide. As part of these discussions, the South Australian Tourism Commission signed a joint marketing agreement to promote our destinations into each other's markets. I had dinner with Mr Gui Guojie and we discussed his interest in Australian Rules Football and the Port Adelaide Football Club.

I travelled to Hong Kong for a meeting with Dr Allan Zeman, the Chief Executive of Lan Kwai Fong Group. Dr Zeman is the billionaire driving force behind a number of major Asian leisure precincts, including Hong Kong's Ocean Park. I sought his advice on the development of Cleland as a major tourism precinct and shared with him some preliminary work that had been done by the Investment Agency. Following that meeting I witnessed an agreement signed between the Hong Kong Arts Development Council and the Adelaide Festival Centre that will facilitate content at the OzAsia Festival and provide the opportunity for South Australian artists to find opportunities in Hong Kong.
